**Sealed Bids:** Sealed bids for the construction of the project titled: **FY 2020 Roadway Resurfacing** for the **City of Donalsonville, Georgia**, will be received until **10:00 A.M., Thursday, December 5, 2019** at City Hall located at 127 East 2<sup>nd</sup> Street, Donalsonville, Georgia at which time and place all Bids will be publicly opened and read. No bid may be withdrawn after the closing time for receipt of bids for a period of sixty (60) days.

**Contractor License:** Any Contractor submitting a bid must be a pre-qualified Georgia Department of Transportation Contractor. **License numbers must be written on the face of the bid envelope.** No bid will be opened unless it contains the Contractor's GDOT license number. See Instructions to Bidders for additional bidding requirements.

**Work to Be Done:** The work to be done shall consist of furnishing all labor, materials and equipment necessary to construct the proposed **FY 2020 Roadway Resurfacing** project as described in the Contract Documents and Specifications. In general, construction consists of the resurfacing of approximately 1.5 miles of roadways within the City of Donalsonville. This work will be awarded in one (1) contract with a **180** consecutive calendar day construction schedule.

**Plans and Contract Documents:** Plans and Contract Documents are on file for review only at City Hall located at 127 East 2<sup>nd</sup> Street, Donalsonville, Georgia. **Bonds:** All bid forms must be accompanied by a Bid Bond in an amount not less than ten percent (10%) of the amount bid. The successful bidder, if awarded the Contract, will be required to furnish a Performance Bond and Payment Bond, each in the amount of one hundred percent (100%) of the Contract amount. All bonds must appear on the Treasury Department's most current Circular 570 Listing.
