Called Council Meeting-June 19, 2017

**Official Minutes**

Mayor Dan E. Ponder, Jr. called the meeting to order at 8:00 AM in the Council Chambers at City Hall. After which Mayor Dan E. Ponder, Jr. gave the invocation, then all joined in the Pledge of Allegiance to the United States of America.

Councilmembers present for the meeting included, Mayor Dan E. Ponder, Jr., Mayor Pro Tem Ed Bond, CP Travis Brooks, CP Flossie Smith, CP Mitch Blanks, and CP Lindsey Register. CP Tony Buczek was absent. Staff present were City Manager Steve Hicks, City Clerk Christina Corvers, Police Chief Woodrow Blue, and Fire Chief Dean King. Guest present: Noma Bush.

Approval of the agenda: CP Brooks made a motion to approve the agenda with CP Smith seconding; motion passed unanimously.

PERMITS & LICENSE: City Manager Hicks recommended the approval of a Beer and Wine License to Noma Bush for Ed's Place to be located at 402 E 3<sup>rd</sup> Street. City Manager Hicks stated that the thirty-day requirement had been met, along with a complete background check. CP Brooks made a motion to approve the Beer and Wine License to Noma Bush, with Mayor Pro Tem Bond seconding. AYES: CP Brooks, CP Smith, and Mayor Pro Tem Bond. NAYS: CP Register. ABSTAINED: CP Blanks. Motion passed.


OLD BUSINESS: City Manager Hicks then recommended the approval of Resolution 06-19-17 to Amend the Alcohol Ordinance to include the revised distance requirements. After a brief discussion on the distance requirements, CP Brooks made a motion to approve the resolution to amend regulations regarding sale of alcohol for on premises consumption and for other purposes to include the revised distance requirements. Mayor Pro Tem Bond seconded. AYES: CP Brooks, and Mayor Pro Tem Bond. NAYS: CP Register. ABSTAIN: CP Blanks, and CP Smith. Motion passed.

NEW BUSINESS: City Manager Hicks recommended the approval of Resolution 06-19-17 A to provide the appointment of the City Attorney. The contract states that City Attorney Billy Grantham will be compensated at a rate of \$400.00 monthly, with \$150.00 hourly for work exceeding the five hours per month. CP Blanks made a motion to approve the City Attorney Contract, with Mayor Pro Tem Bond seconding; motion passed unanimously.

With there being no further business to come before the Mayor and Council, at 8:27 AM Mayor Pro Tem Bond made a motion to adjourn with CP Brooks making a second, and the motion carried.
